Internship may be extended into the Fall

Hours: Total of 160 work hours. Schedules are flexible

Compensation: Unpaid. Benefits may include personal career mentoring, as well as complimentary registration for special events. You may be eligible for University credit for you internship (course/credit must be identified and arranged by intern with counsel from his/her university advisor).

Location: Arizona Citizens Action for the Arts office: 514 West Roosevelt Phoenix Arizona, 85003, On the North West corner of 5th avenue and Roosevelt.

Job Summary:

Under the direction of Arizona Citizens for the Arts (AzCA) and Ear Candy, the intern will be responsible for assisting with the development of ongoing summer music series in downtown Tempe. With the support of these two organizations, the intern will actively participate in the community development of concert productions and non-profit organizations. They will experience, first hand, how to accurately build relationships with community leaders to create lasting partnerships that will enrich the downtown Tempe music community.

Essential Functions:

1. Work closely with a team of interns to develop summer series of concerts
2. Compose letters, emails and other announcements to community leaders.
3. Actively participate behind the scenes of the concerts
4. Assist in follow up discussions within the community

Physical Requirements:

While primarily office based, this position may require sitting for extended periods of time, lifting up to 20 pounds, and in cases of special events, the ability to stand or sit for extended periods of time. Some bending and stretching may be required.

3. Personal Statement: this is a statement that is no longer than 500 words that explains why you are interested in working for Arizona Citizens Action for the Arts. Explain why you have chosen to apply for the specific internship. Tell us your experience (if applicable) as well as what you hope to achieve from this internship.
